Monthly Board Meeting Minutes
Wednesday, September 16, 2020
6:30 p.m.**

- 1. Call to Order** – The meeting was called to order by President Deanna Krumm at 6:31pm.
- 2. Pledge of Allegiance**
- 3. Roll Call** – President Deanna Krumm, Vice President Dennis Hrupka, Clerk Kristine Kordecki, Treasurer Colleen Belmont, Member Curt Nikula, and District Administrator Roger Gahart were all present for the meeting.
- 4. Approval of Agenda** – A Kordecki/Nikula motion was made to approve the agenda as presented. Motion carried 5-0.
- 5. Approval of Board Minutes** - A Belmont/Hrupka motion was made to approve the August 19, 2020 regular meeting minutes as presented. Motion carried 4-0-1 with President Deanna Krumm abstaining.
- 6. Approve Payment of Bills** – A Hrupka/Kordecki motion was made to approve the payment of bills totaling \$236,720.16. Motion carried 5-0.
