1. **Call to Order** – The meeting was called to order by President Deanna Krumm at 6:33pm.
2. **Pledge of Allegiance**
3. **Roll Call** – President Deanna Krumm, Vice President Dennis Hrupka, Clerk Kristine Kordecki, Treasurer Colleen Belmont, Member Curt Nikula, and District Administrator Roger Gahart were all present for the meeting.
4. **Approval of Agenda** – A Kordecki/Nikula motion was made to approve the agenda as presented. Motion carried 5-0.
5. **Action**
  - A. **2020-2021 Budget Development** – No action taken
  - B. **Approval of 2020-21 Teacher Salaries/Compensation** - A Hrupka/Kordecki motion was made to increase the 2020-21 Teacher Compensations by the 1.81% CPI, on the base wage calculation, evenly distributed in accordance with the teachers FTE, and will equal the total increase amount of \$17,261.49. Motion carried 4-1.
  - C. **Approval of 2020-21 Support Staff Salaries/Compensation** - A Belmont/Hrupka motion was made to increase the 2020-21 Support Staff Compensations by the 1.81% CPI, and will equal the total increase amount of \$3,631.44. Motion carried 4-1.

8. **Approval of Budget for Annual Meeting & Budget Hearing Publication** – A Belmont/Kordecki motion was made to approve the 2020-21 Budget for the Annual Meeting & Budget Hearing Publication. Motion carried 5-0.
9. **Adjournment** – A Hrupka/Kordecki motion was made to adjourn the meeting at 10:08pm. Motion carried 5-0.
