- E. **Approval to Join the Walworth County Area School Health Insurance Purchasing Cooperative** – A Belmont/Hrupka motion was made to join the Walworth County Area School Health Insurance Purchasing Cooperative. Motion carried 4-0.

- H. **Approval of 2022-23 Dental Insurance** – A Niklua/Hrupka motion was made to approve the current dental insurance plan with Delta Dental with an 8% premium increase for the 2022-23 plan year. Motion carried 4-0.
- I. **Approval of Bill Payment Until 2022-23 Budget Approval** – A Hrupka/Belmont motion was made to approve the payment of bills until the 2022-23 budget is approved. Motion carried 4-0.
- J. **Set Registration Fees and & Athletic/Activity Fees for 2022-23 School Year** – A Hrupka/Belmont motion was made to keep the Registration and Athletic/Activity fees at the current amount with no increase for the 2022-23 school year. Motion carried 4-0.

**K.
